# CUSTOMS REGULATIONS AND INFORMATION FOR IMPORTS

# HOUSEHOLD GOODS AND PERSONAL EFFECTS

## **Documents Required**

- Copy of Passport
- Detailed inventory list, dated and valued
- Apartment Rental Contract (minimum of 2 years)
- Proof that shipper has been abroad 1 year or more prior to the import shipment
- Employer's Bank Guarantee
- Original Bill of Lading (OBL) / Air Waybill (AWB)
- Original Packing List
- Tax Exemption Certificate (issued by the Bosnian Ministry of Foreign Affairs)

## Specific Information

• For electrical appliances, product information such as serial number, type, make and model should be included on the inventory list.

# **MOTOR VEHICLES**

## **Documents Required**

Original Vehicle Title

## **Specific Information**

• Cars older than 7 years cannot be imported.

## PETS

## **Documents Required**

- Vaccination Record
- Bosnia and Herzegovina Veterinary Certificate
- Rabies Certificate

## **Specific Information**

- Cats and dogs must be vaccinated for rabies at least 30 days but not more than 12 months prior to entry.
- Rabies Certificate must be attached to the Bosnia and Herzegovina Veterinary Certificate.
- Pets other than cats and dogs (e.g., birds, reptiles, small rodents, etc.) are not required to prove rabies vaccinations.
- A failure to comply with regulations may result in a refusal of entry, return home, placement in quarantine, or termination where a return to the country of origin cannot be arranged.

# **RESTRICTED / DUTIABLE ITEMS**

• Hunting weapons and ammunition (special permit required)

- Plant and plant products (permission from the Ministry of Agriculture required)
- Meat products (permission from the Ministry of Agriculture required)

# **PROHIBITED ITEMS**

- Narcotics
- Weapons and ammunition
- Ivory
- Pornographic materials

## **CONSIGNMENT INSTRUCTIONS**

**Recommended:** Contact the destination agent to ensure all requirements have been met prior to import, especially for differences regarding air / sea shipments.
